

People's Endeavour for Social Changes (PESCH)

People's Endeavour for Social Change (PESCH) is a non – profit, non - governmental organization based in Tamenglong and Jiribam districts, Manipur. It works towards the development, capacity building and enlightenment of the vulnerable communities. The organization is spread across 2 states Manipur and Assam. In Manipur it spread in Tamenglong and Jiribam and in Cachar district Assam. People's Endeavour for Social Changes (PESCH) was first established in 1995 and registered in the society registration act in 3rd March 1997. PESCH is led by educated leader with outstanding experiences (13 years) on rural development specifically in the context of Tamenglong and Jiribam districts of Manipur and Cachar district of Assam. PESCH is having current project of Tribal Development Fund(TDF) under NBARD in 4 villages of Tousem, Global Greengrants Fund project in 15 villages of Tousem, ASER under Pratham Education Foundation, Health awarenss programme under MVHA, FPO under NABARD and Skill Development programmes.


PESCH has general body and executive board. The executive board will put up annual programs and any other decisions to the general body. The executive board board is given power to take decision in any related matters of the organization. As and when required some of the decisions will be put to the general body for further approval.

Brief Origin history of the organization:

On 5th August 1995, Late, Rev. Poukhamlung Gonmei and Asampuina Gangmei Dinbui organized areas leaders at Lungbungjang and formed the Soul Winning Development Association (SWDA)with AG. Dinbui as Chairman and Ramdin Kamei as Director. It was renamed as Christian Development Organization (CDO) on 30th October 1995 on Board meeting at Ramgaizang Cachar Assam. Again renamed as Christian Development Society(CDS) on 26 October 1996 and People's Action for Comprehensive Rural Development(PAFCORD) in 13th January 1997. In 23rd February 1997, PAFCORD was modified to People's Endeavour for Social Changes (PESCH) and registered under Society registration at Tamenglong on 3/3/1997.



- B). Natural Resource Management: Regeneration of forest food through forest based intervention activities, Practice of Slope Agriculture Land Techonlogy(SALT) system/integrated/perma horticulture system(orchard tree+livestock+vegetable+fshery), water resource development(terrace farming/kitchen garden), Agro-biodiversity conservation through indigenous seed banks and revival of traditional crops, Seed fair cum food festival for women and youths, Advocacy plan for Judicious use of Natural Resources at village level.





Key Achievements in the year 2021-2022


Enhancing Access to Entitlements: The rural people have little knowledge on various Govt. schemes and program. As a result they do not access to these schemes. Through implementation of Brot/RNBA many people are now aware of many of these programs. 370 families have access to new schemes like Chief-Minister Hakshel gi Tengbang(CMHT), Samajik Suraksha Yojana(SSY), Pradhan Mantri Kishan (PM Kisan), SHG credit linkage, electrical drier machine, rural haat etc. This activity has brought a lot of benefit and is relevant in achieving the project objectives.

Enhancing land rights with focus on women land rights: During the intervention of various awareness programs for various village stakeholders on land rights people now realized legitimate rights of women especially on ownership of land. 10 women of 10 SHGs farm land are recognized and issued land documents by the Village authority and Land owners. As a result of this activity land of women and single women are secured now. This activity also ensured gender equality in the community.

Livelihood improvement (Green Income): The youth and women who have undergone on various Skill training have increased in self-employment in carpentry, handicraft and mushroom cultivation. The SHGs women who received grant from Brot/RNBA also increased self-employment in doing business on local products. They could sell their products in improved way by value addition and updating market price through Market Information Board. The youth and women is observed to have increased their annual income by 20 per cent as compare to baseline data. These activities are relevant to the project objectives and achievement.

Sustainable NRM through Agro ecological Approaches: Through the implementation of Forest food regeneration programs and Traditional crops plantation there is increased in consumption of variety of food in the 5 project villages. At least 4 locally produced food are added to the Food basket through Traditional crop plantation program in all the beneficiary households. The increased availability of various traditional crops seeds in the Seed Banks and Seed Fair contribute more convenient for the farmers in the cultivation. The application of organic compost prepared in the villages in the cultivation also boost the productivity. Through these activities there is increased in biomass in the farms.

Convergence: We PESCH constructed 2 Rural Haat (Sibilong and Kaimai) village supported by National Agricultural Bank And Rural Development(NABARD). The haats was handed over by PESCH to Women SHGs by forming Rural Haat Management Committee. 1 electric drier for king chilli for smokeless at Sibilong supported by Manipur Organic Mission Agency(MOMA). Now SHGs sale their local products in the haat and it increased their income.



Improved quality and dignity of human life through enhanced access to entitlements, land rights, livelihood opportunities and sustainable agro ecological practices, with focus on youth and women in Manipur, India.

Background:

The Project titled: "Improve Quality and Dignity of Human Life New phase-I" is a sixth year programme (April 2017 – March 2024) aiming at empowering people through formation of people's organization, thereby promoting a people's movement towards socio-economic independence. It is implemented in the 5 villages of Tousem block, Tamenglong district, Manipur. The activities implemented during the current reporting period were as follows.

Formation of voluntary youth groups

In this activity we did revival and strengthening of youth clubs in three project villages. Three youth clubs were revived or strengthened one each in three villages.

The first meeting of strengthening youth club was held at Nungkao-ii village on September 14, 2021 at the residence of Mrs. Lungangliu Kamei. It was attended by youth leaders, Village Authority members, and SHG women. The meeting was facilitated by D.Puanthanlung, Coordinator. The meeting attendance were 20 male and 15 female.

The second meeting was held at Rangkekiulongvillage on September 18, 2021 at the residence Ramsinang Kamei, Village Authority Chairman. It was attended by youth leaders and Village Authority members. The meeting was facilitated by D.Puanthanlung, Coordinator. The meeting attendances were 25 male and 15 female.

The third meeting was held at Oinamlong-ii village on September 24, 2021. at the residence Magdalene Gangmei, Secretary Gaiphuam SHG. It was attended by leaders Youth club and Village Authority members. The meeting was facilitated by G. Gaihiamliu, Coordinator. The meeting attendance was 20 male and 12 female.







A. Rural Haat Construction at Kaimai village


1.Introduction:


The Project "Rural Haat Kaimai" was funded by NABARD Regional office Manipur and contributions made by the OC Tousem Police, Women SHGs Kaimai, Village Authority Kaimai, Baptist Church Kaimai and households of Kaimai village. The Project was approved and issued Sanction Letter No: NB.MNR./ 535 /OFDD/ Rural Haat -PESCH/2019-20 dated 17 February 2020 and it was inaugurated by Shri.Namsinrei Panmei, Hon'ble Chairman ADC Tamenglong and Shri. Dr. M.Srinivasa Rao GM/OIC NABARD Manipur Regional Office Imphal on 22nd October 2021. The project experienced initial delays due to National wide lockdown for prevention of Covid-19 pandemics. There were three instalment phases first in the month of March 2021, second in the month of September 2021 and third after the inauguration of the haat. The haat was buit to help rural people market their products effectively.

For the successful exploration of rural markets, a basic requirement is infrastructure. The absence of such infrastructure is aggravating the distribution challenges in rural Tamenglong of India. Due to scattered(geographically), small size of population, remoteness, poor connectivity, low per capita disposable incomes, acute dependent on shifting cultivation the people of Kaimai areas have no opportunity of market connectivity since from the last 20 decades. Leaders of the area approached Government departments, MLA and other agencies for construction of Market Shed in the area, but still none of the agencies heared their voice. With PESCH intervention in the area and NABARD approval of construction in Kaimai opened the eyes of rural people of Kaimai and its neighboring villages to promote trading converting them into small towns. They have now opportunity of selling anything from fresh vegetables, fruits, garments, groceries, agricultural inputs and equipment, consumer expendables and set of spurious products in their local market(Rural Haat). There are 3780 peoples from 7 project villages. There also Assam Rifle, Manipur police, IRB, Railway construction companies and National Highway No.37 visitors whom will buy their. These could be a regular platform to reach out to rural consumers. Branded products like hill broom, king chilli, dry roselle leaf, wild products, sugarcane juice, lemon juice can sales at Rural haat Kaimai, pointing to the opportunity that awaits big brand marketers through SFURTI project under Jiri-Barak Farmers Producer Company under the implementing agency of PESCH. The crucial issue for the marketers is understanding from where and how sellers at these haat source the goods can be a good beginning. Haat sellers mostly sale their local products only and there is great challenge of more sellers than buyers. The major advantage it offers to marketers is touch and feel experience and communication in local language to the rural consumers.

2. About the Rural Haat Kaimai:

2.1. Location: Rural Haat sponsored by Regional Office NABARD Manipur have been constructed at kaimai village which is situated at the western part of Tamenlong District, Tousem Block, Manipur. It is 50 km away from Jiribam district, 87 km from Silchar, 40 km fro Nungba sub Division headquarter and 107 km away from District headquarter Tamenglong. There is 6 km from the Rani Gaidinliu Railway substation Oinamlong which is going to be function after the completion of the Jiri Tupul railway line. Kaimai village is famous in Pineapple, Squaz, orange, Maize and medicinal plants & aromatic in its forest.





2.2.Objective of the project:

The Kaimai village is a junction for neighbouring villages namely; Tollen, Thingchamphai, T.Mutbung, Maokot of kuki villages and Oinamlong and Nungkao of Rongmei villages. Haat is situated near the Tousem police outpost out post of NH-37. It will make comfort to the travellers It will benefit to the travellers and neighbouring villages as hundred of vehicles from light to heavy pass through the village. As there is police check post near the haat, vehicle take stop near the Duirong Kaithean(Rural haat) kaimai.

Objectives: The haat buit to help rural people market their products effectively, to ensured self-sufficient economy of the rural people through the haat, to revive traditional handirafts through connectivity of market, to encourage farmers the importance of local products in the market

2.3.Implementation structure:

The project had a three instalment phase based on formation of Rural Haat Monitoring Committee(RHMC), approval from sub divisional officer and community before the release of first instalment. After received of other stakeholder contribution and community the second phase instalment was released to the implementing organization and then after inauguration of haat the third instalment amount was released.

2.4. Basic Structure /facilities for the Village Haats

The basic structure /facilities which may provide at these village Haats are as under:-

- a. Open raised platforms of 40 length with 40 vendors capacity
- b. Store room for storing products and for Management committee office
- c. 2 cemented Toilets separate for ladies and gents with attached bathroom
- d. Drinking water facility through installation of 500 litre syntax.
- e. 1000 litres syntax for toilet and bath room purpose
- f. Grocery shop for women SHGs to sell local dry products and daily essential items
- g. Boundary wall /fence with cemented pillars
- h. Parking space
- i. Electric connection.
- j. Installation of lemon and sugarcane juice making machine through SELCO Foundation
- k. One Refrigerator for keeping green vegetables under the support of Hon'ble ADC Chairman Tamenglong

3. Maintenance and Management

The Duirong Kaithean (Rural Haat) Management Committee Kaimai and the project implementing Agency (PESCH) in the present of GM/OIC, NABARD, Manipur, Regional Office, Imphal and Hon'ble Chairman ADC Tamenglong enter into this Agreement with the common objective of bringing the purpose of construction Rural Haat to a successful achievements. The Duirong Kaithean (Rural Haat) Management Committee Kaimai shall be responsible for day to day management of the haat, repairing and supporting vendors and visitors. The Haat Management Committee shall give their full support within the terms of this Agreement and in the framework of mutual Partnership, based on transparency and mutual trust. This Agreement lays down the terms and conditions of the cooperation. The Agreement will become effective when signed by President, Secretary of the committee forwarded by GM/OIC, NABARD, Manipur, Regional office Imphal and Hon'ble Chairman ADC Tamenglong.

3.1. Duirong Kaithean (Rural Haat) Management Committee Kaimai

The Haat will purely manage by Women SHGs of Kaimai village. As there is only two SHGs in the village particularly PEACE and MERCY Women SHGs, these two SHGs will manage the Haat and if any new SHGs established in the village then it will become a management committee with the approval from Implementing Agency (PESCH).

The term of the executive committee will be three years and it will be rotation of president, secretary, and Treasurer from the Management Committee (SHGs of Kaimai) after completion of three-year term.

3.2 Executive Committee (Governing body)

a. President: MERCY SHG President

b. Secretary: PEACE SHG Secretary

c. Treasurer: MERCY SHG Secretary

d. Vice Prsident: PEACE SHG President

3.3. Executive Committee Members

- a. All Members of Peace and Mercy SHGs Kaimai
- b. New women SHG in the village (Kaimai) if any

3.4. Advisory Board:

The function of the advisory board is for monitoring management committee activities, settlement of any dispute within the committee, suggestion and support for bringing achievements as per the guidelines of implementing Agency (PESCH) and Donor NABARD. The Advisory board will be Village Authority, PEIH(Village Customary Law Court), Youth Club, Village Development Committee(VDC) and Tanpui phuam. The Advisory board will not be interfered in any roles of the Management Committee.

3.5. Guidelines for vendors

The Duirong Kaithean (Rural Haat) Kaimai is for Kaimai Rongmei and Kuki, Tollen, Thingchamphai, T.Motbung, Maokot, Oinamlong and Nungkao villages. Any person from these villages willing to sell their local products will give opportunity as per following norms

- 1. Registration of their name in the record of management committee
- 2. Rs. 10/- will charge from the vendor per day per head
- 3. Regular vendor can take loan from the Management Committee @ 1 % interest.

3.6. Hiring of Store room for meeting:

Any organizations or department from other villages or area willing to use the store room for meeting purpose, Rs. 500/- will be charge as registration fee.

3.7.PEACE and MERCY SHG Grocery Shop

PEACE and MERCY SHG Grocery Shop will be allotted to consensus candidate within the women SHG members @ Rs. 1000 for the 1-year term. If more than one-person lottery draw system will be done. Payment of rent to the Management Committee shall be last week of every month. If rent is not pay consecutively for two months then permit will be cancel and given chance to other members. If violate the above rules her property can be taken by the management committee.

3.8. Toilet for ladies and gents:

The toilet can be freely use by the vendors and villagers but outsiders or travellers will be charge Rs. 10 per use.

3.9.Fund Use:

The total money receive from the management committee will be audited by church accountant and pastor every last week of the month. The fund can use 10 % for repairing and management of the Haat, 20 % for SHG fund and 70 % for vendors loan.

3.10. Weekly Market Day.

There will be Market Day in every Thursday of the week. Traders from Jiribam and others area will be invite and will allow them to sell their products in the haat and there will be no vendor charge on market day.

3.11. Selling price rate:

The price of local products selling in the haat will be fixe by the Management Committee as per the approval from Village Authority Kaimai village. It is recommended to sell products price in the common rate.

3.12. Amemdment:

If require, amendment or insert any other rules as per the convenient of the committee after completing 1 year of the undertaking with effect from signing by the committee leaders in the presence of GM/OIC NABARD, Regional Office Imphal and Hon'ble Chairman ADC Tamenglong.

4. Monitoring:

People's Endeavour for Social Change (PESCH) will primarily be responsible to monitor the progress of such haats periodically. The concerned NGO will collect information on sale of product, functioning of these haats and furnish the report to NABARD every month or quarterly in Progress Report (MPR/QPR) and on MIS, when it becomes operational.

5.PEOPLE'S PREFERENCE:

Villagers visiting Haat are most interested in purchasing grocery items, as every item is available at the best cheapest price. Traveller visiting Haat are most interested in purchasing local vegetables, fruits and handicraft products. As for the convenience of the people, haat market day have been fixing on Thursday of every week as Friday is the bazar day at Jiribam. The reason for the preference of grocery items is that mostly the villagers are engaged in agricultural occupation, due to which they can easily sell their own products through the Haats.





6.Achievement:

6.1.The Project has been successfully implemented according to the Project guideline and budget. Since from the Inauguration day after women SHGs and some individual sell their products in the rotation system instructed by the Management Committee. Individuals from neighbouring villages started coming to the haat for selling their local products and buying essential items. Buyers like CRPF, Railway companies, Assam Rifle, IRB, Passengers of NH.37, Truck drivers buy chillies, banna stem, banna, widl vegetables, fruits and others locally available products.


6.2.Impacts of Participation of Sangai festival 2019 and orange festival Tamenglong 2019 Peace SHG of Kaimai participated Sangai festival in 2019 and Mercy SHG participated orange festival Tamenglong 2019 under NABARD. So, SHGs have experienced of selling their products outside the village and demand of their local products. Through 2019 impacts, Rural Haat in Kaimai have been granted by NABARD.

7.Sustainability plan: Indicating the likely continuation of net benefits from a development intervention beyond the phase of external funding support. It also includes an assessment of the likelihood that actual and anticipated results will be resilient beyond the project's life.

- **7.1.Mela:** The Haat Management Committee and Implementing agency(PESCH) decided to organize one mela every year in the winter/harvest season to encourage visitors and vendors the importance of haat and its sustainability.
- **7.3. Maintenance charge:** The committee resolved to reserve 10 % of annual income of haat for repairing and beautiful of Duirong Kaithean Kaimai(Rural Haat)
- **8.Best Lesson learned:** After interaction and feedback from the two participants of vendors, they said that "We are very happy to get this kind of opportunity to showcase our products and sale our products in our area which is only our long dream".
- 8.1. They shared among the items they sold were bamboo shoot dry, roselle leaf dry, orange, king chilli fresh and dry with smokeless, millet are the best demand items by visitors.
- 8.2. They shared that well preparation in regard of items packaging (Name of SHG, date of packaging, weight, amount, photo, uses) should be clear.

B) Farmer producer Organisation

Under the NABARD support producer organisation called as Jiri-Barak Farmer Company Limited was formed and registered under the company Act 2013 on 25th August 2020 with CIN NO -U01100MN2020PTC014130

Objectives:

- 1. To carry out hill broom business by collecting hill broom from the members and do value addition by women SHGs members and local youth.
- 2. To cultivate, grow produce, harvest raise or deal in agriculture produce as agriculturist, farmers or gardeners and to set up processing unit for import, export, distribute or deal in agriculture produce of all description, like fruits, vegetables, seeds and herbal products and trade in all the products required for cultivation, harvesting, production and development of seeds, vegetable, fruits, and herbal items.
- 3. To cultivate, grow, produce or deal in agriculture produce and to carry on the business of agriculture, farmers, gardeners, and to acquire hold, buy agriculture land, and deal in such business as may be required by farmers and dealers of agriculture produce.
- 4. To carry on the business of planters, growers and cultivators of seeds, vegetable, fruits and to cultivate, grow, produce or deal in vegetable, fruits and herbs and to undertake the activities for its processing and preservation.
- 5. To manufacture, sell or supply machinery, equipment or consumables mainly to the members and non-members also
- 6. To render technical service, consultancy services, training, research and development and all other activities for the welfare and promotion of the interests of its members.
- 7. To finance the production, procurement, processing, marketing and other activities mention above, including the extension of credit facilities or any other manner of financial services to the members of the company
- 8. To enable producers to get insurance for themselves, their family members, and for the livestock and other productive assets as also for their primary produce.





RELIEF WORK PROGRAMME

Brief Note on Distribution of Brot Relief Commodities during lockdown in the PESCH Project villages

As part of the Bread for the world (Brot) COVID-19 Relief program PESCH has distributed various essential Relief commodities such as rice, dal, potato, mask, hand sanitizer and soap to 175 households and 10 Quarantine Centres in 5current project villages and 1 previous project village on June 3, 2021. The 6 villages are Nungkao, Oinamlong, Kaimai, Sibilong, Chingkao and Kaiphundai.

The essentials commodities were distributed to the selected needy households and quarantine centres who are affected by the COVID-19 pandemic. The PESCH staffs directly went to the villages and hand over the commodities to the individuals and Quarantine centres through the concerned Village Authority, Village Development Committee and Church. The quantities of commodities distributed were Rice – 1250 kg, Dal – 50 kg, Soap–200 pieces, Mask – 300 pieces, Hand Sanitizer – 200 pieces, White phenyl-200 pieces and Detol liquid-100 pieces respectively.

Remark

During the visit to the villages we observed the urgent needs to develop proper infrastructure for the Quarantine Centres, public awareness and SOP for COVID-19 pandemic volunteers. This will prevent spread of the dreaded disease in the community. We are planning to work more on this issue in assisting the affected people.
